

## **Biographical or Historical Note**

The Roswell Manufacturing Company was a textile mill complex that was built by Roswell King, founder of the town of Roswell, and his son Barrington King. It was incorporated in 1839 in Cobb County. Barrington King served as its first president.

By 1860 the Roswell Manufacturing Company consisted of two cotton mills and a factory store. It produced cotton cloth, yarn, rope, and tenting.

During the Civil War, the mill manufactured supplies for the Confederate States of America. The Union army invaded Roswell in July 1864. Union General Sherman sanctioned the destruction of the mills and ordered the more than 400 mill workers, mostly women, to be charged with treason and sent to the North as prisoners.

After the war only one (circa 1854) of the original two cotton mills was rebuilt. In 1882, a second cotton mill was built. In 1926, a fire destroyed the original circa 1854 mill building. In 1923, the mill was sold to William G. Broadfoot of Wilmington, North Carolina and operated under a new charter and a new name, Roswell Mills, Inc. In 1947, Southern Mills, Inc. took over the operation of the mill. Southern Mills ended its operation in 1975.

The Roswell Store was established by and part of the Roswell Manufacturing Company. It sold its own manufactured goods and general merchandise to mill operatives and town's people. Mill workers, in the beginning, were paid with company scrip to be redeemed at the company store. It was also owned and operated by the Roswell Mills, Inc. It was eventually sold to private parties and continued to operate as the Roswell Store until 1964.

## **Scope and Content**

This collection contains a bound copy of minutes of the stockholders minutes, time books, bank records, delivery receipts of goods, deposit receipts from Confederate States of America, and cotton delivery receipts for the mill. It also contains textiles from the mill. The Roswell Store collection contains account books for non-operatives, railroad bills of lading, and a merchant catalog.
